
Re : Our Notice dd. 19/09/2012 Nr. MIP.0951-719-/1394

Reference is made to our abovementioned Notice where we notified that, for work safety purposes, crews of ships calling on Mersin International Port shall not be allowed to walk through the terminal and required that their entry and departure from the port shall be provided by their shipping agencies. However, we noticed that implementation of this matter was not successful. We, therefore and in order to solve this problem, we have the pleasure to state that our company has at its own cost and account allocated a Ring (Shuttle) vehicle to transfer ships' crews from Passengers' Hall Quay through Quay 21 within the terminal area in accordance with the scheduled hours provided in the attached schedule. A sign in both English and Turkish languages shall be hung in a visible place on the windscreen of the Ring Vehicle.

Your Chamber is therefore kindly requested to have its members notify ship masters or ship owners about this specific matter during Ship Inspections.
