Referring to shortages of small shopkeepers, the Minister of Finance told that TBMM accepted a draft of Finance Ministry and by this there are important steps taken, and told "Taxpaying means adding value to this country. When tax is paying regularly, the jobs in this country can be done better."

Mersin Governor stated that Mersin is living historical days and told "Mersin is taking place in 12 cities of Turkey at taxpaying and public income and transferring public sources excess to public."

Mersin Chamber of Commerce and Industry President Şerafettin Aşut told "We as Mersin from the smallest firm to the biggest one make production, create employment, make export, find new markets and integrated Mersin to international formations. Much more importantly, we are one of the top cities at paying tax and amount."

Mersin Union of Chambers of Tradesmen and Craftsmen President Talat Dincer spoke as "Most of the big managements' headquarter is out of the city. When taxing, the endorsements made in here are gone to the center as a result there is a loss happening in the tax proportions. But, Mersin ranks 6 at tax income and 3 at the collection of taxes."
